You will receive an acceptance letter, if you are approved to come. You will also receive a map and your space number.

Sites are 10X10 at a cost of \$30.00 for the weekend. If you require electricity please add \$15.00 to your site fee. If you exceed the 10X10 space, additional sites need to be reserved. Hours for Crafters are Friday - Noon to 6 p.m., Saturday - 10 a.m. to 6 p.m. and Sunday - 10 a.m. to 4 p.m. We welcome you to stay open later if you wish, this will help to keep people in town.

For lodging and camping information, call the Lake Vermilion Resort Association at 1-800-648-5897. Please do Not park on River St. after you have set up, this will allow customers better access. Also we hope to have the St. blocked off on Sat. and Sun. We hope Mother Nature smiles upon us for our festival, if she doesn't our smiles will still brighten the day!
